## Water efficiency discounts for new houses

This form can be used claim for discounted water infrastructure charges for new houses built to achieve a consumption of no more than 100 litres per person per day. There is no equivalent discount for non-household properties.

Houses connecting after 31 March 2018 are eligible for a discount provided a claim has been submitted at the application stage, and prior to the house being occupied. This form should only be used where you have not previously applied for discounts via our mains and/or services application form (typically applications made before 1 April 2018). If you have not yet applied for mains and/or services for your proposed development site, you will have the opportunity to claim infrastructure charges discounts when you make your application.

Please submit a separate copy of this form for each development site that you wish to make a claim for and provide details of the water efficiency of buildings to demonstrate their eligibility for a discount.
